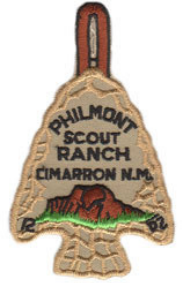

The Blue Water Council Philmont Expedition Committee would like to invite registered Boy Scouts, Venturers, and Sea Scouts to apply for positions on the council contingent for the High Adventure Backpacking Expedition at the Philmont Scout Ranch. There are 20 youth positions available to fill two contingencies.

Youth position requirements are as follows:

- Registered as a Boy Scout, Venturer, or Sea Scout.
- Reached 14 years of age by September 1, 2011, absolutely no exceptions.
- Able to pass a Philmont health physical.
- Agree to live by the Scout Oath and Law during the Philmont Expedition.
- Completed application by deadline of April 1, 2010.

At least one adult male, one adult female (if coed) and 10 youth positions must be filled by April 1, 2010 to keep contingent reservations with the Philmont Scout Ranch.

Youth applications will be accepted and listed in positions on a first come, first served basis. All others will be placed on a waiting list and notified if openings become available.
