Youth position requirements are as follows:

- Registered as a Boy Scout, Venturer, or Sea Scout.
- Reached 14 years of age by September 1, 2011, absolutely no exceptions.
- Able to pass a Sea Base health physical.
- Able to pass a BSA swim test.
- Agree to live by the Scout Oath and Law during the Sea Base adventure.
- Completed application by deadline of May 1, 2010.

At least one adult male, one adult female and four youth positions must be filled by May 1, 2010 to keep contingent reservations with the Florida Sea Base.

Youth applications will be accepted and listed in positions on a first come, first served basis. All others will be placed on a waiting list and notified if openings become available.
